#### 1.2 Approval of the agenda

### 4. 2021 CEQB Priorities (attachments 4.1 – 4.11)

In April 2020, an email was sent to the QB, Board, Chief Executive Officer Group, Admission, Practice and Discipline & Enforcement Officials Groups to consult regulators on QB priorities for 2021. Given that no additional staff is expected to join QB and that it is anticipated that the Covid-19 situation will have an impact on the budget, QB priorities must be selected based on the existing level of resources.

Engineers Canada Board-directed guidelines must proceed (new Public guideline for engineers and engineering firms on the topic of diversity and inclusion and new Public guideline for engineers and engineering firms on the topic of Indigenous consultation and engagement) and projects that are underway should continue (Paper on software engineering and new Aerospace and aeronautical engineering syllabus).

The revised scope for the Feasibility study will significantly increase the workload associated with this project. If this study proceeds, there will be no additional resources to allocate to new priorities and some of the work that was planned for 2020-21 will need to be discontinued. The New proposed Guidelines on fitness to practice and on whistle blowing can be undertaken when additional resources are made available and considered as part of the 2021 consultation process on 2022 priorities. As



discussed during the QB April meeting, a large portion of the work associated with the new Guideline for exam developers will be done under the umbrella of the proposed Feasibility study.

The 2021 priorities that have not been started and received lukewarm support from officials groups in 2020 will not be done and can be considered as part of the 2021 consultation process on 2022 priorities (Guideline on return to active practice, Research paper on Canadian engineers working internationally and new Public guideline for engineers on use of new technology and automation).

The Feasibility study was originally presented as a national academic exam for licensure, but the NAOG raised that a national exam would only be one alternative for the academic assessment of non-CEAB applicants. For that reason, the scope has been broadened to identify and evaluate more tools, including what regulators are using. The title has also been changed to reflect the revised scope of the study. It is anticipated that CEAB members will be asked to contribute to this study to ensure there is fairness in the evaluation of non-CEAB vs. CEAB applicants, and that the impacts that this would bring to accreditation.

The CEQB has previously participated in the development of a feasibility study for alternative methods to assess the experience of applicants for licensure. The structure for the study will be revised as the previous study was conducted over 10 years ago. CEQB members will be asked to provide their input and suggestions on the approach that will be used for the development of this study. A CEQB member expressed their support for this Feasibility study. If approved by the Engineers Canada Board in December, the work would begin in January 2021.

Motion: That the 2021 priorities be sent to the Engineers Canada Board for review and approval, moved by Amy Hsiao and seconded by Frank Collins. None were opposed. The motion carried.
